1. Who we are

2. The collection and use of personal data

Personal data are data that allow you to identify or contact a specific person.

You may be asked to provide your personal information at any time when you contact Qwasp or an affiliate affiliated to Qwasp. Qwasp and its affiliates may share and use this personal information in accordance with this Privacy Policy. They may also bring your personal information together with other information to provide and improve our products, services, content and advertisements.

Here are some examples of the type of personal data that Qwasp can collect and how we can use this personal information.

3. Cookies

We make use of cookies on this website. A cookie is a simple small file that is sent with pages from this website [and / or Flash applications] and stored by your browser on your hard drive from your computer.

You have the right to request access to and correction or deletion of your data. See our contact page for this. To prevent abuse we can ask you to identify you adequately. When it comes to access to personal data linked to a cookie, you must send a copy of the cookie in question.

You can only delete cookies yourself, as they are stored on your computer. Consult the manual of your browser.

Through our website a cookie is placed from the American company Google, as part of the " \in œAnalytics" \in service. We use this service to track and get reports on how visitors use the website. Google may provide this information to third parties if Google is legally obliged to do so, or if third parties process the information on behalf of Google. We have no influence on this.

The information that Google collects is anonymised as much as possible. Your IP address is emphatically not given. The information is transferred to and stored by Google on servers in the United States.

4. Disclosure to third parties

At times, Qwasp may provide certain personal information to companies strategically connected to Qwasp who work with Qwasp to provide products and services or who help Qwasp to sell to customers. For example, when you make a booking, you authorize Qwasp and your provider to exchange information during the activation process to review your application. Once your application for the service is approved, your account will be managed by the respective privacy policies of Qwasp and your provider. Personal data will only be shared by Qwasp to provide or improve products, services and advertisements; personal data will never be shared with third parties for their marketing purposes.

5. Others

It may be necessary for Qwasp "by law, following a lawsuit and / or requests from public authorities inside or outside the country where you live – to make your personal details public. We may also disclose your information if we believe this is necessary or appropriate in the context of national security, law enforcement or other matters of public interest.

We may also disclose your information if we establish that this is reasonably necessary to enforce our terms and conditions or to protect our transactions or users. In addition, in the event of reorganization, merger or sale, we may transfer all personal data we collect to the third party in question.

6. Protection of personal data

Qwasp takes precautions – including administrative, technical and physical measures – to protect your personal information against loss, theft and misuse, as well as against unauthorized access, disclosure, alteration and destruction.

When you use some services or applications or post messages on a social network service, the personal information you share is visible to other users and can be read, collected or used by them. You are responsible for displaying the personal information you choose in these circumstances. For example, if you display your name and e-mail address in a message on a social network service, this information becomes public. Please be careful if you use these functions.

7. Integrity and the storage of personal data

Qwasp makes it easy for you to enter your personal details correctly, completely. We will retain your personal data for the period necessary to fulfill the purposes described in this Privacy Policy unless a longer retention period is required or permitted by law.

8. Sites and services of third parties

The websites, products, applications and services of Qwasp may contain links to the websites, products and services of third parties. Information collected by third parties, which may contain location data and contact information, are managed by their privacy practices. We encourage you to take note of the privacy practices of these third parties.
